Jayne Picott nominated Gus Badali.

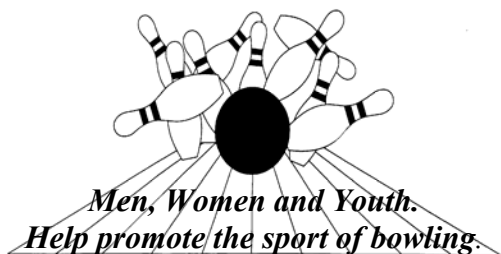
- b) John McLean thanked everyone and respectfully declined.

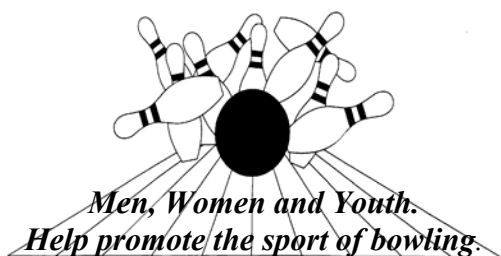
