Annual Youth Tournament – Jayne Picott

- Jayne Picott reported on this year's tournament held at Classic Bowl.
 - The doubles are very successful. This year there were 177 doubles.
 - Last year it was a walk in tournament for the doubles and that caused problems due to the size of it. This year it will still be a walk in tournament but the cut off will be 2 hours before squad.
 - This year we handed out over \$7,000.00 in scholarships.
 - There were 11 bowlers that had the first 9 strikes.
 - There were 3 bowlers that had the first 10 strikes.
 - There were 2 bowlers that had the first 11 strikes.
 - All were boys.
 - Next year there will be no rule changes.
 - The classifications will be re-aligned to better align the divisions.
 - We will be adding an all events division.
 - There will be NO 16:00 squad on Mothers day.
 - The tournament will run for 3 weekends.
 - Next years tournament will be held at Parkway Lanes in St. Catharines.

Family Twosome - Doug Imms

- No rule changes for next year.
- Tournament will be held at Classic Bowl, Mississauga on Feb 7th and 8th, 2009.
- Allowing 2nd place into the tournament this year allowed us to increase the scholarship money from \$1,700 to \$3,000.00

CTF Youth Championships (Sault Ste. Marie) – Laurie Gatto

- The southern Ontario team this year bonded together and captured 28 out of 32 possible medals.
 - 19 Gold, 4 Silver and 5 Bronze.

She won 4 gold and was chosen for the Tournament of America Team that will bowl in Orlando, Florida in July 2008. She also earned a spot on Team Canada 1 week prior to the tournament.

He won 2 gold and 1 bronze Kingston (Natasha Shaw – Senior Girl) She won 1 gold and 1 silver Toronto (Daniel Reid – Senior Boy) He won 1 gold and 2 silver

• Laurie reported that the tournament lost \$2,449.58 this year. This was due to entry fees, grants plus the cost of travel and lineage in 2008.

CTF Youth Championships (Round 1 / Round 2)

- The committee decided to add a new possible award for all events (round 1 and round
- Round 1 will be held at Classic Bowl and round 2 at Primetime Bowl.
- We will be taking a survey to see if the bowlers would like this to be a two day event if possible. (Round 1 on Saturday and Round 2 on Sunday)

Pepsi Cola Tournament – Robert Oliver

- This year's entries were up slightly (5%).
- There are 4 bowlers going to Detroit for the next round.

- iii. Book a room for the Jamboree as well as the Sunday Board meeting subject to the approval by the Board.
- iv. Negotiate with the hall or caterer regarding meals and prices and present recommendation to the Board for their final approval of meal and amount to be charged.
- v. Block out rooms at local hotel(s)/motel(s) so people attending the Jamboree can make reservations at the recommended locations at hopefully lower than normal rates.
- vi. Supply a map to the Provincial Association Secretary-Treasurer including location of the Jamboree, hotels/motels and their rates and phone numbers, to be sent out with the Jamboree notices. This information should be received by the provincial secretaries no later then June 15th.
- vii. If the registration forms are to be returned to anyone other than the Jamboree Coordinator, notify the Provincial Secretary Treasurer so he can put that persons name and address on the registration forms.

b) Jamboree Time:

- i Make arrangements for the seating at the Jamboree including a head table to accommodate the official guests as well as the Provincial Association President and the Association Manager.
- ii Arrange for pitchers of water and drinking glasses at the head table and if possible other tables as well.
- Arrange for tables for literature and information to be displayed on. There should be at least one table for information sent from the CTF National Office. In addition a table for tournament entry forms and the Ontario Tenpin Bowling Council should be set up.

- iv Supply nametags and a check-in facility for the Jamboree as well as people to operate it. (Recommend at least two for check-in and one for the registration and money collection for the added events). We would also suggest a prejamboree registration desk be set up in the lobby, if space permits, at least 2-3 hours before the jamboree starts (for 1-2 hours).
- v Make arrangements for Audio-video equipment if any organization has requested it be available.

- vii A microphone must be provided for the presenters. Depending on the acoustics and layout of the hall, at least 2 floor microphones should be available during the question and answer period.

Since we no longer have a Jamboree the HOF Committee should consider the following change and their timelines for arriving at and the presentation of the award(s).

With no Jamboree the award(s) will probably be presented at the Annual Meeting. Since the committee meets on the weekend of the Annual Meeting (Article V – HOF Committee, paragraph 2) the individual(s) elected would not be formally inducted until the next Annual Meeting in 12 months time. The Committee should look at changing their meeting to possible the weekend of the Fall Board Meeting then the inductions could be done at the Annual Meeting in the same bowling year. This would, though, require the submission date of Feb 1 (Article VI – Nominations – last sentence of paragraph 1) to be changed so the submissions are received prior to the Fall Meeting.

An appeal may be filed within 15 days of the removal. Hall of Fame Bylaws

ARTICLE V - HOF COMMITTEE

The names of all eligible nominees who are not elected shall be reconsidered automatically in each of the four (4) succeeding years, after which time, if not elected; their names shall be dropped from the list of nominees, but may be resubmitted. If any nominees are rejected, the nominators shall be advised, in writing/e-mail, of the reasons for such action.
